

HOI composite score and profile scores range from 0 to 1. The closer the score is to zero, the lower the chances for residents in the census tract to experience the opportunity for good health. Conversely, the closer the score is to 1, the greater the chances that residents will experience high opportunities for good health. You can also gauge health opportunity by looking at the Quintile. Quintile 5 reflects very high health opportunity. Quintile 1 reflects very low health opportunity. Life expectancy can also help gauge health opportunity.
